

Terms & conditions:

1. The tender(s) will be received by the undersigned up to **3.00 P.M. on 14.03.2011** and shall be opened on the same day at 3.30 P.M. if possible. The tender(s) will also be accepted by Registered Post, Speed Post etc. provided that the tender should reach within 3.00 P.M. on or before 14.03.2011.
2. Tenderer(s) should quote their rate(s) both in figure and in words for delivery to the Divisions F.O.R. mentioned above at their own cost, arrangement, risk etc. Quoted rates should be inclusive of all taxes, carrying charges etc as the supply has to be done at respective places by the tenderers at his/their own cost. No separate bill for any additional amount on any ground will be entertained beyond the accepted tendered rate. The tendered rate shall be inclusive of all taxes, duty, and surcharges etc.
3. Tender Envelope must be superscripted as "Tender Notice No., date and the concerned Division/Centre."
4. Tender(s) should be accompanied with **earnest money for Rs.15,000/- (Rupees fifteen thousand) only in the shape of 'Deposit at Call' placed in the name of Executive Director, TFDPC Ltd, Agartala.** No tender(s) will be considered valid if the earnest money is not enclosed as required above along with the tender(s).
5. The tenderer(s) have to be submit Xerox copies of their ITC / PTC and PAN Card along with the tender(s) otherwise tender(s) will be treated as **INVALID.**
6. Earnest money shall be refunded to all unsuccessful tenderer(s) after final decision about acceptance of tender(s).
7. The materials have to be supplied in HPP bags lined with plastic material having 50 kg NET QUANTITY OF FERTILIZER. The bags containing fertilizer should bear the name of the Manufacturer, Registration No, Brand name, if any, and nutrient content in percentage and year of manufacturing etc. as per requirement of Fertilizer (control) order, 1985 and the essential commodities Act.1955.
8. Each successful tenderer has to execute a Deed of agreement with the Corporation in the proforma prescribed by the TFDPC Ltd. for supplying the M.O.P. Fertilizer within 15(fifteen) days from the receipt of the acceptance order.

9. The supply has to be completed in full within 60 (sixty) days from the date of issue of supply order as per terms and conditions of the N.I.T. If the tenderer(s) fail to effect the supply within the stipulated date/period mentioned above, his/their earnest money will be forfeited.
10. **The rates quoted and accepted shall be valid till completion of the supply as per Deed Agreement. No subsequent escalation of price will be acceptable to the Corporation on any ground like increase of Rly.Freight/Transportation cost/Labour charges/wages cost of stitching/ handling charge etc.**
11. Fertilizer Bags found loose, torn, damaged, wet etc. will not be accepted.
12. **Payment will be made on the basis of bills produced showing actual quantity received in good condition, along with production of documents showing payments of all types of taxes, levies etc. Any unpaid Tax(es) and dues applicable shall be deducted from the bills.**
13. The supplier shall be liable to refund the cost of Fertilizer for the quantity which shall be detected substandard by the authority subsequently.
14. Earnest money/Security money will be released after faithful discharge of the contract and final settlement of payment.
15. Undersigned reserves the right to accept or reject any tender including the lowest one partly or wholly without assigning any reason. The supply of fertilizer may be entrusted to two or more tenderers quoting same rates or otherwise, if felt necessary.
16. The quantity mentioned herein may be increased or decreased as per actual requirement at the time of supply.
17. All disputes resulting from this tender notice and actions thereon shall be under the Jurisdiction of Agartala Court.
18. No conditional tender will be accepted.
19. If the office remains closed due to unforeseen reason/ unavoidable circumstances the next working day will be considered for accepting the tender. No further notice will be issued in this regard.
